Terms of Reference (TOR): Website Development for the Coalition of Implementors for Fertilizer and Soil Health (CIFSH)

### 1. Background

The Coalition of Implementors for Fertilizer and Soil Health (CIFSH) is a consortium of four leading organizations—International Institute of Tropical Agriculture (IITA), International Fertilizer Development Center (IFDC), African Plant Nutrition Institute (APNI), and Forum for Agricultural Research in Africa (FARA). CIFSH was launched at the African Fertilizer and Soil Health Summit in Nairobi (May 2024) to promote innovative research and interventions that improve soil health, fertilizer use, and agricultural productivity across Africa. The Coalition aligns with continental frameworks such as the African Fertilizer and Soil Health Action Plan (AFSH-AP) and regional initiatives, and emphasizes private sector engagement, capacity building, and resource mobilization.

  - Inventory of mineral and organic fertilizers
